Final: The final date and time will be announced later in the semester. Faculty members may choose to give an exam or incorporate a project/presentation as a final. If a final exam is not given, class is still held at the scheduled final exam time to complete the required goals and objectives of the course and meet the scheduled required hours.

Due Dates: Each class session on Brightspace includes the assignments due for that session. Class sessions cover work for one week running from Monday – Sunday. Pay close attention to the due dates for assignments within each class session.

Class Discussions: Our Thursday sections each week, will be a required class discussion on Zoom. The topic of the discussion will be announced at the beginning of class. Your participation is mandatory in order to earn up to 15 discussion points for the week. The quality of your answers will determine if you receive the full 15 points.

Report Cards: Each week you'll be required to report to me your progress on all of the assignments and class preparedness (including your current grade). This will serve as a reminder to you of how well you are doing in the course.

Exams: There will be five exams throughout the semester. The exams will not be cumulative. All of the exams will be open lecture notes ONLY, and will involve some combination of multiple-choice, definition, short answer, and essay. The essay questions will always assess some level of critical thinking ability. It will be the essay questions that tell me who really understands the material beyond basic memorization. All exams must be completed online and successfully submitted by the due date. Time to completion is 60 minutes. Exams will not be reopened for a single student no matter what the circumstances. If a technical issue arises that affects the entire class, an exam deadline could be extended.

ONLINE EXAM POLICY: Once you start the exam, you must complete it within the 60-minute time frame. Exams will not be reopened for a single student no matter what the circumstances. It is your responsibility to make sure that you have a reliable internet connection, and time to complete the exam before the deadline. Any loss of internet could result in your exam being auto submitted.

Only if the NICC servers go down or if there is glitch with Brightspace access for the entire college, will the exam due date be extended for the entire class.

All policies regarding academic integrity apply to your conduct with all exams. Only the definitions and concepts provided in lecture are acceptable, and any attempt to copy answers from the internet or another student with even a single question will result in an automatic zero for your entire exam. Further penalties could also apply as stated in the syllabus.

Chapter Quizzes: There is a chapter quiz posted on Brightspace for several the chapters. Although there are 14 quizzes scheduled, your lowest quiz grade will be converted to 20 points at the conclusion of the semester. This means that you have the option of (1) electing to not even take one quiz, or (2) having your lowest quiz converted. All quizzes must be completed online and successfully submitted by the due date. Time to completion is 15 minutes. Quizzes will not be reopened for a single student no matter what the circumstances. If a technical issue arises that affects the entire class, a quiz deadline could be extended.

Writing Assignments: Four times throughout the semester you will be required to compose a paper addressing one of the special topics we cover throughout the semester. All papers must be submitted on Brightspace and will be subjected to a plagiarism review. Papers that involve any form of academic dishonesty will receive a grade of zero, and your case will be reported.

FACULTY/STUDENT INTERACTION POLICY: In this course, regular interaction will occur directly through the weekly discussion and question and answer sessions, as well as indirectly through comments on all graded material. The weekly required Report Card assignments will provide you with the opportunity to pose any questions, comments, or concerns that you may have. My comments on the Report Cards can be viewed once the grade is posted on Brightspace.

In order to view my comments on all graded material follow these instructions:

1) Go into the 'More Tools' menu in the course and choose 'Quizzes' or 'Assignments'

2) Locate the assignment, quiz or exam you want to review. Click the dropdown arrow next to the quiz name and choose 'Submissions'

3) Click on 'Attempt 1' (or whichever attempt you would like to review)

4) That will bring up a page with the results and feedback.

5) Some questions with feedback have a blue link that says 'View Feedback' Click on that to view the feedback for a particular question/answer

Brightspace Course Management

It is expected that you will be logged into our Brightspace course page at least once a week throughout the duration of the course. Course Section Policies

Absence/Illness

Should you need to miss a class for any reason, please contact me as soon as possible. Any absences my require specific documentation in order for extensions to be granted beyond the stated course policy for late assignments. Failure to contact me within one week of a missed assignment or exam will result in the loss of any extensions.

Attendance Recording

The Federal Financial Aid commission requires all faculty to keep daily attendance records on each student. Whenever a student is excessively absent from class, faculty are required to submit that information to the financial aid office. Excessive absences could result in the revocation of your financial aid.

For any student who fails a class, the last date of attendance in the class must also be reported to the financial aid office. A student who fails a class and did not attend class or quit attending class at any point in the semester may be required to reimburse the federal government for any financial aid received for that class.

This class will be conducted as a Flip Model. This means that all of the course lecture videos will need to be viewed in their entirety prior to discussions. Your attendance will be recorded as present for the week if you view the lecture videos in full by midnight every Sunday, otherwise you will be counted as absent.

Please note that as the course instructor I can monitor your behavior throughout our course Brightspace page. This includes the ability to see when you log in, what content you access, and how long you spend looking at it. I can see exactly how much of a lecture video you watch and how many times you accessed the video file. For any lecture videos that are required under the weekly attendance policy, the data must show that you watched at least 95% of the videos otherwise you will be counted as absent for the week. All attendance for the previous week will be recorded on Mondays by noon unless otherwise noted. Any disputes regarding your recorded attendance must be made within 24 hours of the posted attendance on Brightspace. It is your responsibility to monitor your class attendance data closely.

Our class will be conducted via Zoom. The Tuesday class sessions involve an optional Question & Answer Session while the Thursday class sessions (when scheduled) are REQUIRED discussions. The topic of the discussion will be determined at the beginning of class and you must participate in order to earn up to 15 Class Discussion points. The quality of your answers will determine if you receive the full 15 points.

Academic Integrity Violations

Academic dishonesty will not be tolerated in any course at NICC. Plagiarism and other forms of cheating are examples of such dishonesty and are subject to review and possible sanctions as outlined in the NICC Student Conduct Code. You may not, under any circumstances copy Internet material, library articles, or text phrases to claim as yours. I am interested in your ability to explain concepts to me, not someone else's. Consequences for plagiarism will include no credit for the assignment (1st offense); written academic dishonesty statement placed in your permanent record (2nd offense); failing grade for the course (3rd offense).

Cheating on an assignment/activity (copying other student's answers is cheating) or an exam will result in a zero for that worksheet or exam and a written academic dishonesty statement will be placed in your permanent record (1st offense); failing grade for the course (2nd offense). NOTE: Academic dishonesty statements are placed in your permanent record and may affect your academic standing with the college.

Late Work

Late assignments will result in a 50%-point deduction. If you miss an assignment you must contact me within 24 hours of the due date otherwise you are not eligible for submitting late work. You will only have one extra week to complete a late assignment. No late work will be graded beyond one week from the initial due date. No more than two late assignments will be eligible for late submission credit during the course of the semester.

Missing Assignments

It is your responsibility to follow the detailed scheduled assignments as posted in the course calendar. If you miss an assignment you must contact me within 24 hours of the due date. I will determine if your case warrants a make-up opportunity. A 50%-point deduction will be automatically applied, and no make-up opportunities will be granted beyond one week of the original due date.

Makeup Testing

You are allowed to make up only one missed exam for the semester. A second, third, or fourth missed exam is graded as a zero or no credit. You must contact me via email within 24 hours of a missed test in order to be eligible for the make-up. There will be a single make-up test date for this semester:

All make up tests will consist of short-answer questions, and you will have 60 minutes to complete it.

Course Conduct

Camera On Policy:

For all class discussions on Zoom you will be expected to have your camera on unless you have received special permission from me at least 24 hours prior to class. If you attend discussion without your camera on but still contribute to discussion you will be deducted 7 points from the total 15 points possible for your discussion grade.

Tardiness:

Excessive tardiness is rude and disruptive to other students in the class. Class begins at 10:30 and you are expected to be prepared to begin at 10:30. If you have a legitimate reason for being late, please notify me via email. If your tardiness is due to simply not being organized with your day, we will have a discussion to remedy the situation.

Leaving Class Early:

Please do not make appointments that require you to leave class early. If you cannot avoid an appointment and must leave early, notify me prior to the start of class via email. Do not notify me in the minutes before the class begins as I am preparing the lecture at that time. I will make every attempt to make sure that you will be able to earn your discussion points for the week, but I cannot guarantee it. If you leave class discussion early without my approval, you will lose any discussion points you may have earned for the day.

Visitor Policy:

Only registered students are able to attend class Zoom sessions. If someone other than you attempts to attend a Zoom session using your account or if you have a friend attend class with you, I will first

request that the unregistered person leave. If you fail to honor my request, I will remove you from the class Zoom session and block you from re-entering.

Email Response Rate:

It is expected that you will abide by the same email response policy that faculty are required to follow. You need to be checking your NICC email on a daily basis during the academic year. Any emails that I send to you during the workweek (Monday through Friday) will have a 24-hour response requirement. Emails that I send to you on the weekends will have a 48-hour response requirement. Failure to respond to my emails within the required time parameters will result in a penalty including the termination of any granted extensions or exceptions.

Grade Disputes:

Grade disputes on any assignment will be addressed only within one week of the posted assignment grade. It is your responsibility to keep up with your grades on a weekly basis, and not come to me with a dispute weeks or months after the assignment has concluded. If a personal or medical issue prohibits you from discussing your dispute within the required timeframe, you must provide documented proof, and contact me via email as soon as possible.
